Gilda's Club South Jersey recognizes the sensitivity of Personal Information (i.e., information that personally identifies you, including your name, the name of your company, address, email address, phone number, and fax number) that you may place on our website. The information that you provide us is kept in the strictest of confidence. We have no intentions of selling your personal information to third-party businesses. As a result, we have created this statement to express our firm commitment to protect your privacy.

This policy sets forth our practices regarding the collection and use of Personal Information from users of the site. It identifies the following:
